5. Presentation of the Annual Reports

R Plenderleith gave his report including a reflection on the work carried out by Donald Gray, the previous Chairman, and thanked him for his contribution over the years to the organisation.

R Plenderleith highlighted the challenges the Bureau is facing on a daily basis, including the impact of The Cost of Living Crisis. R Plenderleith acknowledged the figures provided by Michelle and highlighted the Client Financial Gains, particularly in benefits awards which totalled over £1.45 million pounds for the residents of Clydesdale, and that this is only possible due to the hard work of the volunteers and staff within the Bureau. R Plenderleith also thanked the Board for their support during his time as Chairman and playing an active part within the role. R Plenderleith also advised the Outreach surgeries were enabling the Bureau to support and reach rural areas within the Clydesdale area.
